content. Whether it's news articles, blog posts, or any written material, our tool assesses the objectivity or

subjectivity of the submitted content. The goal of HonestyMeter is to provide a straightforward and accessible

way for users to evaluate and understand the bias in the information they consume or produce. (Hereinafter

referred to as the "Service")

These Terms include a binding Arbitration Agreement in Section 11 which will require disputes between us to

be submitted to binding and final arbitration.

Please read these Terms carefully, as these, along with our **Disclaimer** and **Privacy Policy** statement forms the

entire agreement between you and HonestyMeter. If you do not accept these Terms in its entirety, then you may

not use the website, or any of our services.

1. ACCEPTANCE OF THE TERMS OF SERVICE

By accessing or using our website, or by using our services, or by clicking on a button or taking similar

action to signify your affirmative acceptance of these Terms, you hereby represent that:

You have read, understood, and agreed to be bound by these Terms and any future updates and i.

additions to these Terms, as published from time to time at the website.

- ii. You are of **sound mind**, at least **18 years** in age (or older as per the valid age of consent in your jurisdiction), and otherwise competent to form a binding contract with us.
